IN FISCAL YEAR 2013, ALMOST 500 VOLUNTEER COURT APPOINTED SPECIAL ADVOCATES (CASAS) SERVED 748 CHILDREN, CHECKING ON THEIR SITUATION, IDENTIFYING NEEDS, AND PROVIDING THE DEPENDENCY COURT WITH RECOMMENDATIONS IN THE BEST INTEREST OF THE CHILD.
