THIS YEAR ALMOST 500 VOLUNTEER COURT-APPOINTED SPECIAL ADVOCATES (CASAS) SERVED ABOUT 840 CHILDREN THROUGH LONG-TERM ADVOCACY, LEARNING ABOUT THEIR LIVING SITUATIONS, IDENTIFYING NEEDS, AND PROVIDING THE COURT WITH RECOMMENDATIONS THAT SERVE THE BEST INTEREST OF THE CHILD. CASAS MAY WORK ON PLACEMENT IMPROVEMENTS, FAMILY VISITATION, AND THE CHILDREN'S MEDICAL, MENTAL HEALTH, EDUCATIONAL AND SPECIAL NEEDS.
